# 1. Appoint City Judge

City Attorney, Thomas Mitchell stated that we have two judges in mind, Judge Steele, He is the Chief Judge from Lawrenceville and Judge Crawford, Chair of the election board for Jackson County. City Attorney stated that Judge Crawford may be a conflict since he is in public office. City Attorney suggested that we hold off on this until he can check on the conflict. # 2. Set court dates for 2020

## 3. Appoint Ethics Commission

Councilmember Ledbetter stated that he is working on setting a commission up to listen to the ethics complaints that are in place. City Attorney stated that this commission will stay active for two years (until 2022). No vote is necessary

## 4. Adopt Purchasing Policy

Justin Kilgore, City Planner stated that there are two options for the council review that JAT Consulting put together. The first policy is a completed updated policy and the second policy is

our existing policy with some adjustments. Both options update the thresh holes.

Councilwomen stated that we had just received this policy late this afternoon and does not feel the council is ready to vote on that one.

## A resolution was created and states:

Should the circumstances identified above arise, staff and the remaining elected officials will act as follows:

- 1. Staff shall alert the Mayor or Mayor Pro Tem to the need for the necessary expenditure.
- 2. Staff will take any necessary steps (obtain bids, proposals or a purchase order).
- 3. The bid, proposal, purchase order, or other documentation will be posted at City Hall for 24 hours and notice of the necessary purchase shall be place on the City's website.
- 4. The Mayor or Mayor Pro Tem and one other Council member shall approve the purchase in writing.
- 5. Upon such approval staff may proceed with the purchase and pay the vendor or service provider.

Motion to approve Resolution 2020-001, by Astin, second by Ledford, All in favor

# 5. Appoint Citizen Advisory Board

Councilmember Astin suggested that we need to investigate this further before voting. Motion to table, Ledbetter, Second by Astin, all in favor.

# 6. Approve Municode Purchase

City Planner, Justin Kilgore stated that we do have this in budget this year for \$15,000.00. We do have a standing contract and has not updated since, November 2, 2015. Mr. Kilgore would as the council for us to proceed with this project.
