

Business Development Along I-85 Corridor Hoschton Participants

- 71.5% Alignment "Jackson County needs to limit future business growth and development along the I-85 corridor <u>until the impact of current and planned</u> <u>development on local communities, farm land and traffic flow is addressed by</u> <u>leadership and local developers." (68.3% county-wide)</u>
 - 12.2% Alignment "Light business development should be fostered and encourage by Jackson County along the I-85 corridor that compliments and supports current business and limited further impact on housing, core communities and farm land." (14.5% county-wide)
 - 11.1% Alignment "Industrial business development, distribution warehouses and manufacturing should be fostered and encouraged by Jackson County along the I-85 corridor provided that it is environmentally sound and located away from housing, core communities and farm land (12.6% county-wide)
 - 3.3% Alignment "Jackson County needs to attract as much industrial development, distribution warehouses and manufacturing as it can along the I-85 corridor... continue moving full speed ahead (3.7% county-wide)
